Sub: Posting of Air Customs Superintendent to Trivandrum International Airport against 25% quota for outside Commissionerates -Reg

With reference to letter F.No.S14/167/2018-Estt dated 17.01.2019 of the Deputy Commissioner of Customs (Estt), Chennai VIII Commissionerate, Chennai and with the concurrence of the Chief Commissioner of Central Tax and Central Excise, Thiruvananthapuram Zone, the following Superintendent is posted as Air Customs Superintendent to Air Customs Pool, Trivandrum against the existing vacancy towards 25% quota, with immediate effect in terms of Ministry's letter F.No.A-11019/102/91-Ad.IV dated 21.10.1993 showing distribution of posts sanctioned for Trivandrum International Airport among Custom Houses.

- 2. The officer will have a tenure of maximum 2 (two) years from his date of joining but will be subject to any change in policy from time to time.
- 3. While working against the said post, he will be treated as on deputation but will not be entitled to any deputation (duty) allowances. He will draw pay at the

same rate as admissible to him from time to time and subject to the condition as applicable to other Central Government staff posted to Trivandrum.

- **4.** He is further informed that he is liable to be reverted to his parent post at any time without any notice or assigning any reasons for the same.
- **5.** As regards other terms and conditions of appointment, it will be the same as applicable to him in his parent post.
- **6.** He should join the new place of posting on or before **15.02.2019**, failing which the posting order will be treated as cancelled.
