

**Sub: Extension of Deputation period for the 6<sup>th</sup> year in Central Tax & Central Excise, Thiruvananthapuram Zone-Reg**

In pursuance of letter C.No.II/13/27/2013 CC(KZ) I dated 29.01.2019 of Additional Commissioner (CCO), Thiruvananthapuram Zone and letter F.No.II/3-6/Admn/CCO/MCX-I/2013 dated 15.01.2019 of the Deputy Commissioner (CCA), GST and Central Excise, Mumbai Zone, the deputation period of **Smt. Saraswathi Rammohan, Superintendent of Central Excise** is extended till her superannuation on 31.08.2019 in Thiruvananthapuram Zone.
