It is further informed that this financial upgradation, as personal to the incumbent for the stated purposes and restriction of the Assured Career Progression Scheme for financial and certain other benefits (House Building Advance, allotment of Govt. Accommodation, advances etc.) only without conferring any privileges related to the higher status (eg. Invitation to ceremonial functions, deputation to higher posts, etc.), shall be ensured for grant of benefits under the Assured Career Progression Scheme.

3. The officer will have to exercise option for pay fixation in terms of Department of Personnel & Training's OM dated 26.09.1981 and 19.11.1987 within one month. The pay shall be fixed under the provisions of FR 22(1) a(1), subject to minimum financial benefit of Rs. 100/- as per the Dept. of Personnel & Training OM No. 1/6/97- Pay.I dated July 5, 1999. The financial benefit allowed

under the Assured Career Progression Scheme shall be final and no pay fixation benefit shall accrue at the time of regular promotion. The financial upgradation shall be purely personal to the officer and shall have no relevance to his seniority position.
