2. As you aware, the Dispute Resolution Scheme has been operationalized as Sabka Vishwas (Legacy Dispute Resolution) Scheme, 2019 from 01.09.2019 to 31.12.2019. The Rules in this regard has been issued as Sabka Vishwas (Legacy Dispute Resolution) Scheme Rules, 2019 vide Notification No.05/2019 Central Excise(NT) dated 21.08.2019. As informed vide above referred letter, an intensive out-reach programme to create awareness among the eligible tax payers should be undertaken, informing them about the scheme. I urge you all to collaborate with the trade and industry to make this Scheme a grand success.

3. In pursuance of the Rule 5 (2) of Sabka Vishwas (Legacy Dispute Resolution) Scheme Rules, 2019, Designated Committees in respect of the Commissionerates under Thiruvananthapuram Zone, have been constituted. The details are at Annexure enclosed herewith.
