
2. All controlling officers of the Commissionerate/Divisions/Ranges are directed to observe the "Vigilance Awareness Week" in adherence with the Circular cited above.
3. The observance of the week will commence with the Integrity Pledge at **11.00 A.M. on 28<sup>th</sup> October 2019** in the Central Tax & Central Excise Auditorium, 5<sup>th</sup> Floor, C.R. Building. The respective Heads of Offices shall administer the pledge in the field formations. The Integrity pledge to be administered (English and Hindi version) is available in the CVC website. Sufficient copies of the pledge may be made available to all field formations and these may be displayed on the Notice Boards.

4. Banners/posters may be displayed in all the field formations under your charge. The Vigilance Awareness Week shall be used as an occasion to highlight the awareness about effective preventive measures undertaken through system improvements and use of information technology to fight corruption.

5. It may also be ensured that expenses incurred in connection with observance of the week be monitored closely to avoid profligate expenditure by way of bringing out glossy brochures etc.
