

**Sub: Recruitment Rules for the post of Superintendent of Central Excise –
 Mandatory Training for Inspectors.**

This refers to the Recruitment Rules for the post of Superintendent of Central Excise in Level 8 in the Pay Matrix under CBIC, Department of Revenue, Ministry of Finance, notified in the Gazette of India vide GSR 249 dated 05.08.2019.

2. As per the new Recruitment Rules (RRs), the eligibility criteria for Inspectors for promotion to the post of Superintendents are two (2) years regular service in the grade, and successful completion of 2-4 weeks training as prescribed. NACIN Zonal Campus, Cochin plans to organize 3-4 weeks training programme for Inspectors, who have not undergone Induction Training as Inspectors, to fulfil the eligibility criteria.

3. In view of the above, it is requested that details of all Inspectors of Kerala Zone, who have not undergone Induction Training as Inspectors, be provided at the earliest to take necessary action in this regard.
