
**Sub:- SPARROW-CBIC - Online writing of APARs for the period

2. The completed APARs/No Report Certificates (NRC) for the year 2018-19 in respect of Group 'B' and 'C' Officers have been sent for officers' disclosure. However, only 146 APARs have been submitted for closing and around 184 APARs are still pending in their inbox of SPARROW-CBIC ('MY PAR' Tab).
