Sub: Promotion to the grade of Superintendent of Central Excise & Customs-reg.

Shri. Jose K.M., Inspector of Central Tax & Central Excise is hereby notionally promoted to the cadre of Superintendent of Central Excise, Group 'B' post, on regular basis, in the pay band of Rs. 9,300-34,800 (PB-2) with G.P Rs.4,800/- in pre-revised scale plus such allowances as may be applicable with effect from 30.06.2011 and until further orders. His Seniority in the cadre of Superintendent is assigned immediately below Shri. Prasannakumar P.G. and above Shri Padma Kumar N.P. in the revised Seniority List as on 01.01.2014 published vide C.No.II/34/5/2014 Estt. dated 09.01.2017.

- 2. The promotion order issued is subject to the condition that the officer mentioned above should assume the higher post immediately not later than 03.01.2020, failing which it will be treated that he has not accepted the promotion *ab initio* and all consequences arising as a result of non acceptance of promotion shall follow.
- 3. The officer is not entitled for arrears of pay, for the period of notional promotion preceding the date of actual promotion.

- 4. The officer will have to exercise the option for pay fixation in terms of DoPT O.M dated 26.09.1981 and 05.07.1999 within one month from the date of issue of this order. Option once exercised shall be final.
- 5. The promotion of the Inspector to the grade of Superintendent is subject to the outcome of SLP No. 20810/2012 filed by the Department against High Court Order dated 28.03.2012 and any other pending cases in concerned Courts/Tribunals.
- **6.** The compliance report about joining/non-joining of the officers should be sent to this office by **07.01.2020**.
- 7. Specific posting orders to the officer will be issued in due course.
