ORDER NO. 35/2020

Sub: Representation of Shri. P. Kamaruddeen, LDC, for reversion to the grade of Havaldar – Reg

Shri. P. Kamaruddeen, Lower Division Clerk is transferred to the grade of Havaldar under FR – 15 (a) as requested by him vide his representations dated 10.02.2020 and 13.03.2020.

2. This order will take effect only after Shri. P. Kamaruddeen furnishes an undertaking to the effect that:

- a. He understands that he is being reverted on his own request and will lose lien over the post of LDC forthwith.
- b. He understands that he will be considered to have resigned the post of LDC and will not be entitled to count his service on the grade of LDC for any purpose.
- c. He is willing to be placed as junior most in the grade of Havaldars as on the date of joining.
- d. His pay will be fixed as per the clarification issued by DOPT vide OM No.12/1/2016-Estt (Pay-I) dated 31.03.2017.

3. If he fails to furnish the undertaking as above on or before **31.03.2020**, this order will be treated as cancelled.
