2. The officers posted to Airport are posted for a period of 2 (two) years and the officers posted to ACC (UB) are posted for a period of 1 (one) year without prejudice to the right of the Department to transfer them earlier on administrative exigencies.
3. The above officers should join their new place of posting latest by **20.07.2020**, except the officers at Sl. Nos 2 and 77. The officer at Sl. No. 2 shall be relieved from Airport, Karipur on or after 26.07.2020 and the officer at Sl. No. 77 shall join Airport, Karipur only after 26.07.2020.
4. Controlling officers shall ensure that the officers are relieved from their previous post only after proper relieving/ handing over notes are mutually exchanged so as to ensure smooth transition.
5. In case of officers posted to Audit Commissionerate and DGGI formations, the Relieving Officers shall ensure that the officers who are being relieved are clear from vigilance angle, as on date of their relief.
6. No representation shall be entertained from any officer before his/ her joining the new place of posting.
7. Report compliance by **31.07.2020**.
8. All the representations received till date regarding transfer and posting in the cadre of Inspectors stand disposed off.
