

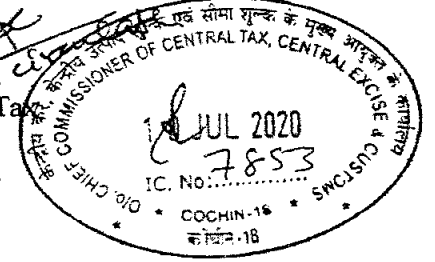

Sub:-Preparation of panel for deputation in the cadre of Senior Intelligence Officers and Intelligence Officers in the Directorate General of Goods and Service Intelligence (DGGI), Coimbatore Zonal Unit - reg.

The Directorate General of GST Intelligence, Coimbatore Zonal Unit is in the process of drawing up a panel of willing and suitable officers for filling up the posts of **Senior Intelligence Officer and Intelligence Officer at Zonal Unit, Coimbatore and its Regional Units at Madurai and Trichy on deputation basis** as mentioned below. It is proposed to fill up the vacancies by appointing suitable officers from the respective grades of Customs and GST formations. The details of vacancies are as under :-

2. The selected officers, while working in the Directorate General of GST Intelligence on deputation basis, will be entitled for Deputation Allowance as admissible in terms of OM No.2/22(B)/2008-Estt.(Pay.II) dated 03.09.2018 (as amended) of Ministry of Personnel, Public Grievances and Pensions, DOP&T, New Delhi. The Officer, who is selected, however, will have to make his / her own arrangements for residential accommodation.

3. Normally, the deputation is for a period of 5 years which is extendable by another two years, subject to the willingness of the officer, his / her performance, concurrence of his/her parent Commissionerate and approval of the Competent Authority.

4. It is requested that the circular may please be brought to the notice of all the formations under your jurisdiction and the application of willing officers may please be forwarded to this office. The Officers may indicate their preferences among the three locations. While forwarding the names of the willing officers, the following information in respect of them may be furnished for evaluation by this Directorate.

- (a) Complete bio-data and willingness letter of the officer along with history of previous postings;
- (b) ACR / APAR gradings for the last five (5) years i.e. up to 2018-19 duly verified and attested by the Additional/Joint Commissioner(P&V);
- (c) Up to date Vigilance Clearance Certificate; and
- (d) "No Objection Certificate" from the Competent Authority to relieve the officer in the event of his / her selection.

5. It may be brought to the notice of the Officers that once they are selected, they will not be allowed to withdraw their option and they are expected to serve in DGGI, CoZU till the expiry of their tenure of 5 years.


6. In case, while working in this Directorate, if the conduct and work of the officer is found not satisfactory, then the officer shall be reverted to their parent Commissionerate prematurely without assigning any reasons.

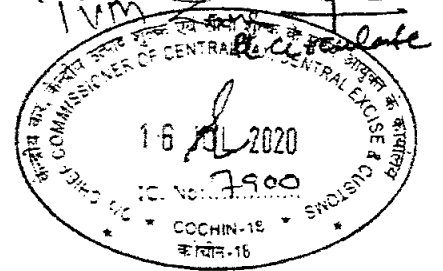

Sub: Preparation of panel for appointment of Intelligence officer in the Directorate General of Goods and Services Tax intelligence, Kochi Zonal Unit in 7 CPC Pay Matrix Level-7 deputation basis-Reg.

The Directorate General of Goods and Services Tax Intelligence, Kochi Zonal Unit is in the process of drawing a panel of willing and suitable officers for filling up the vacancies in the grade of Intelligence Officer on deputation for the Kochi Zonal Unit at Kochi.

2. There are four (4) vacancies in the grade of Intelligence Officer on deputation basis in DGGSTI, Kochi Zonal Unit as per DGCEI F.No. A-428/22/13/2017-Estt(Ptl) dated 04.07.2017. It is proposed to fill up these vacancies by appointing suitable officers from the grade of Inspectors of Central Tax, Central Excise & Customs.

3. The Selected officers, while working in the Directorate General in the grade of Intelligence Officer on deputation basis, will be entitled for deputation allowance, as admissible. Normally the deputation is for a period of five years, subject to the willingness of the officer, his/ her performance, concurrence of his parent Commissionerate and approval of the Competent Authority. It may also be pertinent

to mention that the option for deputation basis in DGGSTI once exercised cannot be withdrawn under any circumstances. Officer having minimum 3 years of experience in the field may exercise their willingness through proper channel. Experience in Preventive/ Anti-evasion is preferable.

4. It is requested that the circular may please be brought to the notice of all formation under your jurisdiction and the application of willing officer be forwarded to this office. While forwarding the name of the willing officer, the following information may also be sent for evaluation by this Directorate General.

- 1) Complete bio-data and willingness of the officer along with history of previous postings.
- 2) ACR/APAR gradings for the last 5 years including the year 2017-18 (duly verified and attested by the Addl./Joint Commissioner (P&V))
- 3) Vigilance clearance and
- 4) 'No objection' from the Cadre Controlling Authority to relieve the officers in the event of his selection.

5. The above information/details may kindly be arranged to be furnished to this Directorate General by 31.07.2020.
