Please refer to this office letter of even number dated 17.08.2020 regarding online writing of APAR for the period 2019-20 in respect of Group 'B' & 'C' Officers (with Grade Pay Rs. 1900/- and above) in SPARROW-CBIC.

Though the last date for submission of self-appraisal to the Reporting Officer was **31<sup>st</sup> August 2020**, due to system issues, SPARROW-CBIC system will be kept open to allow self appraisal **till 7<sup>th</sup> September 2020**. Many of the Officers are yet to submit their APAR online in SPARROW-CBIC. The List of Officers Reported upon, who are yet to submit the APAR online, is uploaded in the website of Kochi Commissionerate.

All the Supervisory Officers need to ensure that all Group 'B' & 'C' officers under their jurisdiction should forward their APARs to the Reporting Authority immediately in SPARROW-CBIC, after completing self appraisal in Section-II of APAR. The process is to be closely monitored by the Deputy/Assistant Commissioners concerned and report compliance by 08.09.2020.

Further, as per the letter F.No.40/BVS/DGHRD(HRM-1)/SPARROW/2020 dated 12.06.2020, the due date by which the report to be completed by Reporting Officer and Reviewing Officer for the reporting period 2019-20 is **30<sup>th</sup> September 2020** and **15<sup>th</sup> November 2020** respectively. Hence, all the concerned officers are requested to complete their task within the stipulated time.
