Sub: Inter Commissionerate Transfer) in the grade of Tax Assistant - Reg.

Smt. Leena Singh, Tax Assistant of CGST & Central Excise, Vadodara Zone is hereby transferred to Central Tax & Central Excise, Thiruvananthapuram Zone on Inter Commissionerate Transfer, purely on spouse grounds as per Ministry's instructions issued vide F.No.A-22015/23/2011-Ad.III A dated 27.10.2011 and in terms of DoPT's Office Memorandum F.No. 28034/9/2009-Estt (A) dated 30.09.2009 and Central Excise and Customs Department Tax Assistant (Group 'C' post) Recruitment Rules, 2014 and other relevant instructions issued from time to time.

2. The transfer will be effective from the date when the officer reports for duty in Central Tax & Central Excise, Thiruvananthapuram Zone and subject to the following terms and conditions:

- a) That her seniority will be fixed below the last Tax Assistant in Central Tax & Central Excise, Thiruvananthapuram Zone i.e. she will be treated as junior most in the cadre of Tax Assistant.
- b) No transfer TA/ joining time etc, will be admissible to her in connection with this transfer.
- c) She will not be considered for confirmation and promotion in the parent Commissionerate.
- d) She will be liable to be transferred anywhere within the jurisdiction of Central Tax & Central Excise, Thiruvananthapuram Zone.
- e) Her seniority in the cadre of Tax Assistant will be fixed and intimated in due course.

3. The officer should join Thiruvananthapuram Zone on or before **16.10.2020** failing which this order will be treated as cancelled.
4. This is issued with the approval of the Chief Commissioner of Central Tax, Central Excise and Customs, Thiruvananthapuram Zone.
