Kindly refer to the Circular No. 131/2021 dated 23-01-2020 issued by the Central Board of Indirect Taxes & Customs, New Delhi regarding Standard Operating procedure to be followed by exporters and various reports received from DGARM, New Delhi declaring certain exporters as "Risky" based on the risk profile of such exporters and their suppliers.
