ZONAL COVID RESPONSE TEAM (ZCRT)

Thiruvananthapuram CGST, Central Excise & Customs Zone, Kerala

In the context of mounting number of COVID cases and various restrictions in place to control the spread of pandemic, following arrangements are made to support the COVID affected officers and their families working in Central GST, Central Excise and Customs Commissionerates and Directorates in Kerala. To avail the facilities, the COVID affected working/retired officers and their family members are expected to contact the ZCRT officers as listed below in their region (preferably on the same day of getting the test result confirming COVID infection). The ZCRT officer who receives the call, thereafter, shall pass on the details on real-time basis with his counterparts in the region. In case, if the affected officer or his family members require any support for hospitalization/consultation with doctor/transport/food etc., he/she shall intimate the same to the ZCRT officer. The ZCRT officer and other members shall identify suitable medical facilities /service providers in various locations within their Region, so that all possible support required can be extended to the affected officers at his nearest location.
