**Sub: Completion/Closure of APARs in SPARROW-CBIC for
APAR cycle 2020-2021 – Reg.**

Please refer to this office letter of even number dated 16.11.2021, 07.12.2021 and 22.12.2021, circulating APAR 2020-2021 pendency position in SPARROW-CBIC with a request for completion of all pending APARs by concerned officers.

In this connection, it may be pertinent to mention that although the due dates for acceptance of APARs or making representation have elapsed, requisite action to fully close the APARs/NRCs in the system is still pending at almost all level of Group 'B' & 'C' officers concerned. As on date, a total of **55 APARs and 3 NRCs** of Group 'B' and 'C' officers for 2020-2021 cycle are still pending closure. It is observed that, in all cases, APARs after due disclosure continues to lie with the officers.

It may be noted that, after closure of APAR cycle 2020-2021 by NIC, no action can be undertaken in the system on pending APARs/NRCs for 2020-2021. Therefore, in cases where the requisite actions/steps are not completed in system by the concerned officer/custodian before closure by NIC, officers may suffer/face difficulty for such APARs/NRCs at later stage. APARs attain finality and become available in system for view/retrieval only after final closure of the APAR by the custodians in the system (after

completion of all steps). It is therefore kindly requested to impress upon all officers in your jurisdiction to complete the requisite action on APAR 2020-2021 immediately. A detailed list of such pending APARs/NRCs is enclosed.

The matter may be treated as **'MOST URGENT.'**
