CIRCULAR

In view of the sudden increase in the number of Covid-19 (Omicron variant) positive cases in the country and recent incidents of many of our officers testing positive in the Hqrs Office, the following guidelines are issued. All officers and staff are requested to strictly adhere to the guidelines in this regard, failing which strict vigilance action will be initiated against the violators.

1. All officers/staff who attend office shall strictly follow COVID-19 appropriate behaviour including **strict and proper wearing of mask**, physical distancing, use of sanitiser and frequent hand washing with soap and water.
2. **No unnecessary visits to other sections/senior officers/colleagues should be made** and all such interactions should be made over phone only.
3. **Anyone with symptoms of Covid-19 (cold, cough, fever, etc.) or those who had any primary contact with any persons who turned Covid-19 positive are requested to stay away from office** and follow the quarantine/testing guidelines of State Health Authorities in this regard .
4. Anyone coming to office after interstate/international travel are also requested to follow the latest guidelines of quarantine issued by State Health Authorities in this regard.
5. **Even if alone at your on desk/section, all are requested to wear face mask all the time** as the new variant spreads much faster through respiratory droplets.
