Smt. S. Lekha, Inspector (Retired) of Central Tax & Central Excise is hereby notionally promoted to the cadre of Superintendent of Central Tax & Central Excise, Group 'B' post, on regular basis, in the pay band of Rs. 9,300 – 34,800 (PB-2) with G.P. Rs. 4,800/- in pre-revised scale plus such allowances as may be applicable with effect from 04.11.2014 and until further orders. Her Seniority in the cadre of Superintendent is assigned immediately below Smt. V. Rajini and above Shri U. Balan in the revised Seniority List as on 01.01.2014 published vide C.No.II/34/5/2014 Estt. dated 09.01.2017.

2. The officer is entitled for arrears of pay, if any, for the period of notional promotion till the date of her retirement.
3. The officer will have to exercise the option for pay fixation in terms of DoPT O.M. dated 26.09.1981 and 05.07.1999 within one month from the date of issue of this order. Option once exercised shall be final.
