In terms of the provisions of Rule 48(1)(a) of CCS (Pension) Rules, 1972, the Commissioner of Central Tax and Central Excise, Kochi is pleased to permit Shri Roy Jose, Superintendent, CGST Hqrs, Thiruvananthapuram Commissionerate to retire voluntarily from Government Service with effect from **31.03.2023 A.N** subject to all relevant conditions as applicable to Government servants under Voluntary Retirement Scheme pursuant to his representation dated 22.02.2023.
