ORDER NO. 58/2023**Sub: Promotion to the grade of Executive Assistant – Reg.**

The Review DPC meeting held on 30.05.2023 reviewed the proceedings of the DPC meeting held on 30.12.2022 for promotion of Tax Assistants to the grade of Executive Assistants in view of Ministry's letter F.No.A.12018/01/2012.AD.III.B dated 15.05.2023.

2. As per the findings of the aforesaid Review DPC, the following officers, who were originally promoted to the grade of Senior Tax Assistant (re-designated as Executive Assistant) vide Order No. 84/2017 dated 31.03.2017, are hereby provisionally regularized in the grade of Executive Assistant (Group 'B' Non-Gazetted), as their promotion to erstwhile Senior Tax Assistant is subjudice and to enbloc them above the officers who are to be promoted to the grade of Executive Assistant by virtue of relaxation in qualifying service granted by the Ministry vide letter F.No.A.12018/01/2012.AD.III.B dated 15.05.2023.

5. The officers are eligible for pay fixation from the date of notional promotion, but no arrears would be admissible till date of joining in the grade of Executive Assistant.
