4. In case of officers posted to Audit Commissionerate and DGGI formations, the Relieving Officers shall ensure that the officers who are being relieved are clear from vigilance angle, as on date of their relief.
5. No representation shall be entertained from any officer before his/ her joining the new place of posting. All representations received as on date have been disposed of.
6. All officers under orders of Transfer vide Order no. 69/2023 dated 23.06.2023 who have not been relieved, stands relieved with immediate effect.
