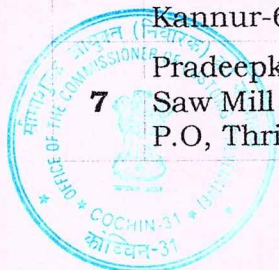
TRADE FACILITY CIRCULAR NO-02/2023

Subject: Appointment of approved Valuers for valuing Gold and Silver Jewellery for Import/ Export from various Airports in Kerala and for the purpose of valuation of seized/confiscated gold, silver etc. - reg.

Attention is drawn to the trade and public regarding appointment of approved valuers for valuing Gold and Silver Jewellery as well as Jewellery studded with precious stones/synthetic stones, for export and import from various Airports in Kerala (TRV/COK/CCJ/CNN).

2. The following panel of Jewellery experts has been constituted with the following persons as Valuers for valuing Gold Jewellery and Silver Jewellery as well as Jewellery studded with precious stones/synthetic stones for export from/Import at various Airports in Kerala as well as for valuation of seized/confiscated Gold/Silver in all forms, Gold/Silver Jewellery and Jewellery studded with precious stones/synthetic stones at Airports.

3. It is clarified that the above appointed valuers are bound to comply with the directions of Commissioner issued from time to time as required, including to do valuation work anywhere under the jurisdiction of Customs Preventive Commissionerate.

4. The fees to be charged by registered valuers for valuation of any asset shall not exceed the amount calculated at the following rates based on the market value, namely:

(a) On the first Rs.5 lakhs of the asset as valued	1/2 per cent of the value
(b) On the next Rs.10 lakhs of the asset as valued	1/5 per cent of the value
(c) On the next Rs.40 lakhs of the asset as valued	1/10 per cent of the value
(d) On the balance of the asset as valued	1/20 per cent of the value

5. Where the amount of fees calculated is less than Rs.1,000/-, the appointed valuer may charge Rs.1,000/- as fees.

6. The charges of approved Valuers shall be paid by the Importer/Exporter concerned. In respect of seized goods/consignments taken up for disposal by the Department, the charges shall be paid by the Department.

7. Trade is hereby advised to engage the services of the above valuers to facilitate the valuation of gold and silver jewellery as well as jewellery studded with precious stones/synthetic stones for export from/Import at various Airports in the state of Kerala in terms of the notification pertaining to the jurisdiction of CCP, Kochi.

8. This Circular shall be effective from the date of issue.
