Sub: Promotion to the cadre of Superintendent of Central Excise & Customs - reg.

Smt. Geetika Chib, Inspector of Central Tax & Central Excise is hereby promoted to the cadre of Superintendent of Central Tax & Central Excise, Group 'B' post, on ad-hoc & in-situ basis, in Level-8 of the Pay Matrix (corresponding to pay band of Rs. 9,300- 34,800 (PB-2) GP – Rs. 4,800/- in pre-revised scale) plus such allowances as may be applicable. The officer should join the higher post immediately. Her seniority in the cadre of Superintendent is assigned w.e.f 26.07.2023 and placed immediately below Shri. Badal Gaffoor A and above Shri. Aravind Kumar Kajla.

2 . The officer will have to exercise the option for pay fixation in terms of DoPT O.M dated 26.09.1981 and 05.07.1999 within one month from the date of issue of this order. Option once exercised shall be final. The officer who has already been granted Financial upgradation under Assured Career Progression Scheme/Modified Assured Career Progression Scheme is not entitled for pay fixation benefits now.

The promotion of the Inspector to the grade of Superintendent is subject to the final outcome of SLP No. 20810/2012 filed by the Department against High Court Order dated 28.03.2012 in OP (CAT) No. 4305/2011, OP (CAT) No. 999/2012, OP (CAT) No.998/2012, OP (CAT) No. 968/2012, O.A. SLP(C) No: 16161/2018 in Hariharan vs Harshavardhan case now pending with the Larger Bench of the Hon'ble Supreme Court and any other pending cases in concerned Courts/ Tribunals.
