## ORDER No. 22/2024

Sub: Proforma Promotion to the cadre of Superintendent of Central Tax & Central Excise - reg.

The following Inspectors of Central Tax & Central Excise, who are presently working on deputation have been granted Proforma Promotion to the grade of Superintendent of Central Tax & Central Excise, Group'B' post, in Level-8 of the Pay Matrix (corresponding to pay band of Rs. 9,300-34,800 (PB-2) GP – Rs. 4,800/- in pre-revised scale) plus such allowances as may be applicable with effect from **04.12.2023** i.e., date of promotion of their immediate junior.

- 2. The above mentioned officers working on deputation shall continue to work in the capacity of the post to which they had been selected on deputation, and shall be eligible to draw salary at higher grade only after repatriation from the deputation and after joining the cadre at the promoted post.
- **3.** The effective date of promotion for the purpose of seniority shall remain the date of order of promotion (i.e. **04.12.2023**).

- **4.** No further extension of deputation period, beyond what is approved, shall be allowed for above mentioned officers opting for proforma promotion.
- **5.** If the officer does not opt for proforma promotion or does not return to accept regular promotion, it shall be deemed that the officer has refused promotion.
- **6.** The competent authority, Central Tax & Central Excise, Kochi has considered the application for Proforma Promotion to the cadre of Superintendent of Central Central Tax & Central Excise in respect of the following officers and decided as under.
