**2.** The Officers from Sl.No 47 to 92 who are posted to Commissionerate of Customs (Preventive), Cochin will be posted to Air Customs formations by specific orders issued by the Commissioner of Customs (Preventive), Cochin.

**3.** The officers who are to be posted from Commissionerate of Customs (Preventive), Cochin to Air Customs formations are subject to vigilance clearance of the officers as on date. Before posting to the respective formations [i.e., Airport, ACC(UB) or ACC(I&E)], the competent authority shall ensure that the officers are clear from vigilance angle for the purpose. The officers who are to be posted to Airport/UB/ACC(I&E) are for a period of 1 (One) year without prejudice to the right of the Department to transfer them earlier on administrative exigencies.

**4.** Controlling officers shall ensure that the officers are relieved from their previous post only after proper relieving/handing over notes are mutually exchanged so as to ensure smooth transition. The officers are to be relieved from their present place of posting by **31.05.2024** and to join their new place of posting latest by **11.06.2024**. Controlling officers will be held responsible if the officers are not getting relieved within the stipulated time. The officers who are not being relieved on 31.05.2024 (not applicable for officers working in the Airports) will be deemed to be relieved on that date.

**5.** In case of officers posted to Audit Commissionerate, DGGI and DRI, the Controlling Officers shall ensure that the officers who are being relieved are clear from vigilance angle, as on date of their relief.



6. The officer at Sl.No 115 may be relieved only on or after 12 August 2024.
7. No representation shall be entertained from any officer before his/ her joining the new place of posting. All representations received as on date have been disposed off.
8. This is issued with the approval of the Chief Commissioner of Central Tax, Central Excise & Customs, Thiruvananthapuram Zone.
