Sub: Notional promotion to the cadre of Superintendent of Central Tax & Central Excise – Reg.

Shri. Shatrughan Kumar (D.O.B – 02.01.1989), Inspector of Central Tax & Central Excise is hereby notionally promoted to the cadre of Superintendent of Central Tax & Central Excise, Group 'B' post, on ad-hoc basis, in Level-8 of the Pay Matrix (corresponding to pay band of Rs. 9,300- 34,800 (PB-2) GP – Rs. 4,800/- in pre-revised scale) plus such allowances as may be applicable with effect from 04.12.2023 i.e., the date of joining as Superintendent of his immediate junior, Shri. Viresh Mishra.

2. The officer's seniority in the cadre of Superintendent is assigned immediately below Shri. Kamal Kumar and above Shri. Viresh Mishra.
3. The officer is entitled for arrears of pay, if any, for the period of notional promotion preceeding the date of actual promoton. The officer will have to exercise the option for pay fixation in terms of DoPT O.M dated 26.09.1981 and 05.07.1999 within one month from the date of issue of this order. Option once exercised shall be final. If the officer has already been granted financial upgradation under MACP Scheme, then he shall not be entitled for pay fixation benefits now.

The promotion of the Inspectors to the grade of Superintendent is subject to the outcome of SLP No. 20810/2012 filed by the Department against High Court Order dated 28.03.2012 in OP (CAT) No. 4305/2011, OP (CAT) No. 999/2012, OP (CAT) No.998/2012, OP (CAT) No. 968/2012, O.A. No. 180/00806/2014 in CAT (EB) and any other pending cases in concerned Courts/Tribunals.
