- 2. The posting to Air Customs formations are subject to vigilance clearance of the officers as on date. Before relieving the officers to the respective formations [i.e., Airport, ACC (UB) or ACC (I&E)], the competent authority shall ensure that the officers are clear from vigilance angle for the purpose. The officers posted to Airports/ UB/ I&E are for a period of 1 (One) year without prejudice to the right of the Department to transfer them earlier on administrative exigencies
- 3. Supervisory officers shall ensure that the officers are relieved from their previous post only after proper relieving/handing over notes are mutually exchanged so as to ensure smooth transition. The officers, except the new recruits, are to be relieved from their present place of posting by 30.05.2025 and to join their new place of posting latest by 10.06.2025. The new recruits are to join immediately on their relief. Supervisory officers

will be held responsible if the officers are not getting relieved within the stipulated time. The officers who are not being relieved on 30.05.2025 will be deemed to be relieved on that date (not applicable for officers working in the Airports).

- **4.** In case of officers posted to Audit Commissionerate, DGGI and DRI, the Controlling Officers shall ensure that the officers who are being relieved are clear from vigilance angle, as on date of their relief.
- **5.** The officers posted to Appeals Commissionerate in excess of the sanctioned strength of the Appeals Commissionerate are to be posted on loan basis from the strength of CCO.
- **6.** The officers who are attending Induction Training at NACIN Kochi can join their new place of posting on completion of their training.
- 7. No representation shall be entertained from any officer before his/ her joining the new place of posting. All representations received as on date have been disposed of.
- **8.** This is issued with the approval of the Chief Commissioner of Central Tax, Central Excise & Customs, Thiruvananthapuram Zone.
- **9.** The controlling officers are to report compliance by **12.06.2025.**
