CORRIGENDUM TO ORDER Nos. 22/2025 & 23/2025

As per Para 3 of the Order Nos. 22/2025 and 23/2025, both dated 23.05.2025, it was mentioned that the officers are to be relieved from their present place of posting by 30.05.2025 and the officers who are not being relieved on 30.05.2025 will be deemed to be relieved on that date.

Representations has been received from the All India Association of Superintendents of Central Tax, Kerala Unit as well as from many other formations requesting that the relief date may be extended and the deemed relief clause may be modified to enable the officers to discharge their statutory functions without any ambiguity.

Further, in view of the ongoing recovery operations in connection with the accidental capsizing of MV MSC ELSA-3 and the subsequent drifting and beaching of wrecked containers along the southern coast of Kerala, many officers have been posted on temporary basis from various Commissionerates to strengthen the operations undertaken by Customs under Operation Theera Raksha.

Under these circumstances, the Order Nos. 22/2025 and 23/2025, both dated 23.05.2025 have been modified to the extent that the officers are to be relieved from their present place of posting by 10.06.2025 and the deemed relief clause has been removed.
