**Subject: Posting of Tax Assistants (TAs) in the O/o Commissioner (IT & CV), CBIC,
Delhi from Field Formations of CBIC on loan basis – reg.**

The office of Commissioner (IT & CV) proposes to appoint three (03) Tax Assistants on loan basis from field formations for an initial period of two years extendable by one more year.

2. Accordingly, applications are invited from willing officers. The officers will be selected based on aptitude and suitability to the area of working in the grade of Tax Assistant.

3. In view of above, you are requested to bring this circular to the notice of all the formations under your charge & forward the applications of the willing officers to this office. While forwarding the names of willing officers, the following information may be furnished:

- (a) Complete Bio-data of willing officers in prescribed proforma.
- (b) ACR/APAR gradings of last three years.
- (c) Vigilance Clearance.
- (d) 'No objection' from the Cadre Controlling Authority to relieve the officer in the event of her/his selection

4. The willing officers may submit their application within one month from the date of issuance of this circular. The period of loan will be for an initial period of two years extendable by one more year subject to the individual's performance on the post.
