On acceptance of this Central Tax and Central Excise Commissionerate's Offer of appointment of even no. dated 16.03.2026, **Shri. Prasanda Kumar P.S.**, a candidate recommended for appointment to the post of Assistant Halwai-cum-Cook in Central Tax and Central Excise Department, Thiruvananthapuram Zone, under **UR/ESM category**, is appointed as Assistant Halwai-cum-Cook in Central Tax and Central Excise, Thiruvananthapuram Zone on temporary capacity, subject to verification of character and antecedents, in Level – 2 in the pay matrix (Rs. 19,900–63,200) plus such allowances as may be sanctioned by the Government of India with effect from **30.03.2026 (F.N)**.

2. Shri. Prasanda Kumar P.S. is informed that he will be on probation for a period of two years from the date of appointment. If on the expiration of the period of probation or any extension thereof, as referred to in Para 2 above, the appointing authority is of the opinion that the above candidate is not fit for permanent absorption or if at any time during such period of probation or extension thereof, is satisfied that he will not be fit for permanent absorption on the expiration of such period or extension, the appointing authority may terminate his services or pass such orders as he thinks fit.
