Sub: Promotion to the cadre of Superintendent, Central Tax & Central Excise, Thiruvananthapuram Zone – Reg.

The following Inspectors of Central Tax & Central Excise are hereby promoted on regular basis to the cadre of Superintendent of Central Tax & Central Excise, Group 'B' post, in Level-8 of the Pay Matrix plus such allowances as may be applicable with effect from the date of assuming charge of the higher post and until further orders.

The promotion of the Inspectors to the grade of Superintendent is subject to the final outcome of SLP No. 20810/2012 filed by the Department against High Court Order dated 28.03.2012 in OP (CAT) No. 4305/2011, OP (CAT) No. 999/2012, OP (CAT) No.998/2012, OP (CAT) No. 968/2012, OA Nos. 523/2023, 527/2023, 543/2023 & 344/2024 of CAT (Ernakulam Bench) and the judgment in Civil Appeal arising out of SLP(C) No: 16161/2018 in Hariharan vs Harshavardhan case now

pending with the Larger Bench of the Hon'ble Supreme Court and any other pending cases in concerned Courts/Tribunals.

3. The officers are promoted to the grade of Superintendent in an officiating capacity until their juniors are promoted to the grade of Superintendent, after which that newly promoted officers will be considered to be in officiating capacity. A total of six officers of unreserved category who are junior most in seniority will be in officiating basis at all times until further orders. The officers at Sl. No. 1 & 2 can assume the charge immediately and the officers at Sl. No. 3 & 4 can assume the charge on or after 01.05.2026. All the officers will have to assume charge not later than 12.05.2026.

4. As the Officer at Sl. No. 1 is on deputation to COIN outside the country, the officer shall assume the charge of Superintendent only after re-joining the parent Zone, and not later than 12.05.2026. If not, it shall be treated as a refusal of promotion.

5. As the Officer at Sl. No 2 is posted on deputation basis outside Thiruvananthapuram Zone, the officer may accept the promotion not later than 12.05.2026. If accepted, the officer shall join the parent zone by discontinuing the deputation or alternatively requesting for proforma promotion on or before 12.05.2026.

6. The compliance report about joining/non-joining of the officers should be sent to this office by 15.05.2026.
