Sub: Appointment to the grade of Havaldar on Compassionate grounds- Reg.

On acceptance of this Central Tax and Central Excise Commissionerate's offer of appointment issued vide GEXCOM/II/(3)/63/2021-Estt dated 15.05.2026, **Kum. Krishna Ashok**, a candidate selected for appointment as Havaldar on Compassionate grounds under **UR category**, is appointed as Havaldar in Central Tax and Central Excise, Thiruvananthapuram Zone on temporary capacity, subject to verification of character and antecedents, in Level-1 in the pay matrix (Rs.18,000-56,900) plus such allowances as may be sanctioned by the Government of India with effect from **18.05.2026 (F.N)**.

2. You are informed that you will be on probation for a period of two years from the date of appointment. The Appointing Authority may, if she thinks fit, extend the period of probation.

3. If on the expiration of the period of probation or any extension thereof, as referred to in Para 2 above, the appointing authority is of the opinion that you are not fit for permanent absorption or if at any time during such period of probation or extension thereof, is satisfied that you will not be fit for permanent absorption on the expiration of such period or extension, the appointing authority may terminate your services or pass such orders as she thinks fit.

4. You are also informed that your appointment is provisional and is subject to the verification of Character and Antecedents certificate being verified through proper channel. In case your Character and Antecedents are found not verified or any false information is given by you in your self-declaration, the provisional appointment letter will be cancelled forthwith without assigning any further reason and without prejudice to such further action as may be taken under the

provisions of the Bharatiya Nyaya Sanhita, 2023 or any other Act, for the time being in force.
