Sub: Posting of officers to the Offices of Authorized Representatives (OARs) at the GST Appellate Tribunal (GSTAT) State Benches of Kerala and Lakshadweep – Calling for willingness from eligible officers – Reg.

The Central Board of Indirect Taxes and Customs (CBIC) has initiated the creation of Offices of Authorized Representatives (OAR) at various locations across India for representing departmental cases before the Goods and Services Tax Appellate Tribunal (GSTAT). In this connection, suitable officers are proposed to be selected and posted to these offices, along with necessary secretariat support, to effectively handle and represent departmental matters before the Tribunal.

2. Accordingly, willingness is invited from officers of the cadres of Superintendent, Inspector, Executive Assistant, Tax Assistant and Havaldar under Central Tax & Central Excise, Thiruvananthapuram Zone for posting to the GSTAT State Benches of Kerala and Lakshadweep located at Ernakulam.

- iv. Date of joining the present cadre.
- v. Brief details of experience in legal, adjudication, audit, appeals, review, GST, or litigation-related work, if any.

4. The willingness from officers may be consolidated and forwarded to this office so as to reach on or before **26.06.2026**. Applications received after the stipulated date or those that are incomplete and do not contain the requisite particulars will not be considered.

5. It may be noted that submission of willingness does not confer any right to posting and that the final selection and posting of officers shall be subject to administrative requirements and the approval of the competent authority.
