Sub: Posting of Air Customs Superintendent to Cochin International Airport, Nedumbassery against 25% Quota – Reg.

Willingness is invited from Superintendents against the posts of Air Customs Superintendent allotted to Central Tax & Central Excise, Thiruvananthapuram Zone at Cochin International Airport, Nedumbassery in Airpool against 25% quota. The terms & conditions for selection and posting at Cochin International Airport, Nedumbassery as Air Customs Superintendent are as follows:

- i) The officer posted at the Airport will be eligible to draw pay and allowances at the same rates admissible to them from time to time.
- ii) He shall be considered as on deputation to the Airport, but no deputation allowance is admissible to him/her.
- iii) Normally, the period of deputation at the Airport is two years. However an officer at the Airport can be reverted before completion of 2 years without any reason.
- iv) The officer posted at the Airport will have to make his/her own arrangements for residential accommodations.
- v) The officer will also be entitled to draw uniform and diet allowance as admissible under rules.
- vi) In the event of their promotion to the higher grade the officer will be liable to be reverted back to their parent Commissionerate or posted anywhere as may be ordered by the competent authority in this regard.
- vii) The following officers are not eligible for consideration for posting at Cochin International Airport, Nedumbassery:

- A. Officers transferred out of Airport/sensitive places on administrative grounds.
- B. Officers due for retirement upto 31.07.2029.
- C. Officers with less than 2 years cooling off period on their return from Airport /DRI/DGGI/NCB/ED.
- D. Officers with Vigilance/ Non-Vigilance cases.
- E. Officers against whom penalty is operative.

2. Willingness may be called for from eligible Superintendents with the following particulars:

- i) Name
- ii) Place of Posting
- iii) Date of Birth
- iv) Date of promotion as Superintendent
- v) Whether worked in any airport/DGGI/ DRI /NCB/ED, If so details

3. Willingness received may be submitted to this office latest by 20.07.2026. Willingness received after the stipulated date will not be entertained.
