2. The conditions of appointment are enumerated in the **Annexure**. If they accept the offer of appointment on the basis of the stipulated conditions, **they should report for joining the post of Inspector of Central Excise on or before 15.10.2015** before the Commissioner, Central Excise Hqrs., Central Revenue Building, I. S. Press Road, Cochin-18.
