Subject: Delay in forwarding proposals for grant of financial assistance for medical expenses /ex-gratia claims from the field formation - Reg.

Attention is invited to DGHRD's D.O. letters dated 16.03.2011, 01.09.2011, 21.12.2011, 06.08.2012 & 09.06.2014 issued from time to time on the subject.

2. In this regard, Member (P & V.) CBEC, has noted that there continues to be delay caused from the field formation in forwarding medical claims for grant of financial assistance from the Welfare Fund for the expenses incurred by them on medical treatment of self/dependents (which were not reimbursed under CGHS/ CS (MA) Rules). Her observation in this regard are :-

"Though the Governing Body is empowered to condone the delay, the discretionary powers of the Governing Body should be used sparingly and only in the most deserving/exceptional cases."

3. As per the Consolidated Guidelines (on page 72 of the book "HRD IN CBEC") the claims are to be forwarded by the Commissioner/HOD **within one month of the receipt of the request** filed by the applicant. It has been noticed that delays are norms rather than an exception. It is once again reiterated that the claims from the Welfare Fund should be submitted in time as per norms and mechanism be devised in Chief Commissioner/Director General's offices to monitor the same.

4. Timely monitoring of pendency will enable DGHRD to fulfill the mandate of welfare of departmental officers/staff through the Welfare Fund.
