2. As per the time-schedule prescribed in the DOP&T's O.M. No. 35034/3/2008-Estt. (D) dated 19th May, 2009, the Screening Committee meeting for considering the cases of all eligible officers during the period 01/10/2015 to 31/03/2016 is to be held in July, 2015.
