- They are informed that they will be on probation for a period of two years from the date of appointment. The Appointing Authority may, if he thinks fit, extend the period of probation.
- If on the expiration of the period of probation or any extension thereof, as referred to in Para 2 above, the appointing authority is of the opinion that candidate is not fit for permanent absorption or if at any time during such period of probation or extension thereof, is satisfied that he will not be fit for permanent absorption on the expiration of such period or extension, the appointing authority may terminate his services or pass such orders as he thinks fit.
- They will have to play for the Department team for a minimum period of 5 years. Selected candidates' performance will be watched, attendance for the practice sessions will be counted during the probation period in addition to their performance of official duties.
- The above candidates are also informed that their appointment is provisional and is subject to the caste/ tribe certificate being verified through the proper 5. channel and if the verification reveals that their claim to belong to OBC/SC/ST as the case may be, is false, their services will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under the provision of the I.P.C. or any other Act, for the time being in force, for production of false certificate.
