On acceptance of this Central Excise, Custom & Service Tax Commissionerate Offer of appointment of even no. dated 29.10.2015, the following candidate selected under Sports Quota is appointed to officiate as Havaldar in Central Excise, Customs & Service Tax, Kerala Zone on temporary capacity, subject to verification of character and antecedents, in the pay Band of Rs.5200-20200 plus Rs.1800/- (Grade Pay) plus such allowances as may be sanctioned by the Government of India with effect from 5th November, 2015:-

2. He is informed that he will be on probation for a period of two years from the date of appointment. The Appointing Authority may, if he thinks fit, extend the period of probation.

3. If on the expiration of the period of probation or any extension thereof, as referred to in Para 2 above, the appointing authority is of the opinion that the candidate is not fit for permanent absorption or if at any time during such period of probation or extension thereof, is satisfied that he will not be fit for permanent absorption on the expiration of such period or extension, the appointing authority may terminate his services or pass such orders as he thinks fit.

4. He will have to play for the Department team for a minimum period of 5 years. Selected candidates' performance will be watched, attendance for the practice sessions will be counted during the probation period in addition to his performance of official duties.

5. The above candidate is also informed that his appointment is provisional and is subject to the caste/ tribe certificate being verified through the proper channel and if the verification reveals that his claim to belong to OBC/SC/ST as the case may be, is false, his service will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under the provision of the I.P.C. or any other Act, for the time being in force, for production of false certificate.


